## DRILL-STATUS GUARDSMAN: OFFICER

**POSITION:** Budget Officer (Traditional)

**MAXIMUM MILITARY GRADE:** Major (O-4)

**AREA OF CONSIDERATION:** Open to current members of the Nebraska Air National Guard or members eligible to join the Nebraska Air National Guard with the ability to commission to 2d Lt, or currently ranked 2d Lt to Major. THIS IS A CROSS TRAINING OPPORTUNITY AND A COMMISSIONING OPPORTUNITY.

**QUALIFICATIONS:** This position coincides with the full time T32 Budget Officer Dual Status Military Technician advertised on USAJobs. Interested personnel must apply for the full time T32 position to be considered for the traditional officer position. Applicants must be able to commission to 2d Lt, or already be commissioned with the rank of 2d Lt to Major. Applicants must be able to obtain the 65F AFSC per the Air Force Officer Classification Directory if they are not already qualified, obtain DoD FM Level II certification within two years of starting and have 4 years retainability.

**DUTIES:** Individual must exhibit strong, effective leadership capabilities. Ability to effectively communicate both orally and in writing to all levels of personnel. Understand Air Force doctrine and core leadership competencies and communicates these to the force. Ability to independently identify weaknesses and develop solutions that are effectively implemented with successful results. Knowledge of Air Force finance structures, procedures, and systems preferred but not required.
