## VACANCY ANNOUNCEMENT

**Position Title & Unit:** EW SERGEANT, HHC, 67TH MEB, Para 117, Line 5

**Location:** Lincoln, NE

**Military Grade Range:** SGT/E5 - SFC/E7 **CPMOS:** 29E40

**Military Requirements:** A physical demands rating of medium. A physical profile of 222221. Normal Color vision. Qualifying scores. A minimum score of 100 in aptitude area SC, ST and EL in Armed Services Vocational Aptitude Battery (ASVAB) test. A U.S. citizen. Civilian/military education. A Soldier must be a high school graduate or equivalent and completed high school algebra course or equivalent. In-service accession Soldiers must have successfully completed the Warrior Leader Course. All prior service, including (other services) must complete WLC prior to attending the 29E course. The only exception will be those prior service including (other service) personnel who attend a leadership school that has been approved by the Army for equivalent WLC credit. A Soldier must meet a security eligibility of Secret and be eligible to receive a TOP SECRET (TS) and Sensitive Compartmented Information (SCI). For a listing of all qualifications for the award of this MOS, they can be found in DA PAM 611-21.

**Area of Consideration:** All eligible members of the Nebraska Army National Guard and individuals who are eligible for Enlistment or transfer into the Nebraska Army National Guard who meet the grade requirements stated in Military Grade Range listed above. In order to be promoted in this position, the Soldier must be on the current STEP list and fully qualified for promotion IAW AR 600-8-19. Soldiers not holding the requisite NCOES for their current grade must agree to complete all NCOES/SSD Requirements within one year of assignment.

### **General Requirements:**

1. Currently assigned in the Nebraska Army National Guard with a rank in the range listed in Military Grade Range.
2. Not currently "Flagged from Favorable Personnel Actions" or under a "Bar to Reenlistment"
3. Meet other requirements as stated in **Military Requirements** above.

**Summary of Duties:** Perform the MOS 29E Soldier advises and assists the commander or command EWO, as applicable, regarding use of the electromagnetic and directed energy to control the EMS and defeat the enemy through planning, coordination, integration, and execution of Electronic Attack (EA), Electronic Protection (EP), and Electronic Support (ES). Responsible for all EW administrative, training and operational matters; planning and execution of operations involving Army EW air and ground platforms; coordination with higher for Airborne Electronic Attack (AEA) support; preparation of staff estimates; responsible for the EW element of the MDMP and orders production process; resolves all interoperability issues; coordinates resolution of spectrum de-confliction with S6; preparation, establishment and maintenance of SOPs and TTPs; establishes, oversees and monitors all echelon EW training; may assist or supervise company Counter Radio-Controlled Improvised Explosive Device EW System (CREW) Specialists as necessary or required to ensure an effective CREW Electronic Counter Measure (ECM) Force Protection (FP) program.
