Position Title: CBRN NCO (7219)

Location: 72nd Civil Support Team, Bellevue, NE

Military Grade Range: Minimum SPC/E4(P) - Maximum SGT/E5

Military Requirements: Designated MOS is 74D. Selected individual must become MOS qualified within 12 months of appointment. Assignment incurs 3-year obligation to unit post CSSC completion. Selectee will be on response alert 24 hrs/365 day a year, TDY frequently, and work some evening and weekends. Must possess and maintain a valid SECRET security clearance. Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.

Qualified applicants will be referred to the selecting official in the following order.

Area 1: Lateral Transfers of **on-board** AGR personnel (SGT/E5) MOS 74D qualified. Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: Select Train Educate Promote List (STEP) of on-board AGRs CPMOS qualified (SPC/E4, 74D).

Area 3: N/A

Area 4: All members of the Nebraska Army National Guard, or those eligible to become members currently holding the rank of SPC/E4(P) and above. This position is SGT/E5 and a reduction will be required for any selected applicants above the rank/grade SGT/E5 prior to AGR start date.

General Requirements:

- 1. Have Knowledge of the organization and structure of the Air and Army National Guard.
- 2. Complete the "WMD-CST OSHA Respirator Medical Evaluation Questionnaire" and add to application documents. This form can be downloaded from the Nebraska National Guard Opportunities webpage.
- 3. Normal color vision is required.
- 4. Required to live within 60 miles of unit location.
- 5. Selectee will be required to complete Anthrax and Smallpox immunizations.

Summary of Duties: Enter areas of possible contamination to identify and assess CBRNE hazards; determines the source of the hazard and the extent of the contamination; participate in the collection of chemical and biological samples; initiate WMD CST chain of custody procedures and maintain the teams capability to properly set-up and operate state of the art CBRN equipment; know CBRN antidote administration; safe patient extraction; crime scene preservation techniques; perform all operational tasks while wearing all levels of PPE; able to identify NATO and TIC placards. Utilizes the established checklists and code words in reporting the detection, identification and sample collection actions in the Hot Zone/contaminated area. Total technical training requirements for this position are 739 hours, which must be completed within 3 years of assignment in addition to applicable MOS and NCOES schools. May be assigned additional duties based of Unit and Section needs.

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail, postal mail, or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
