Position Title: Flight Facility Commander (10609)

Location: JFHQ-DAVN, Grand Island, NE

Military Grade Range: Minimum MAJ/O4 – Maximum MAJ/O4

Military Requirements: Designated assignment for this position is 15A/15B. Selected individual must become MOS and UH-72/CH-47 Pilot in Command (PIC) qualified within one year of AGR start date. Must have a current flight physical. Must possess and maintain a valid SECRET security clearance. **Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.**

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. **All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.**

Qualified applicants will be referred to the selecting official in the following order.

Area 1: Lateral Transfers of **on-board** AGR personnel (MAJ/O4) MOS 15A/15B qualified. Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 4: Current Officers of the Nebraska Army National Guard member in the rank of MAJ/O4 with preferred AOC of 15A/15B.

General Requirements:

1. Must be a U.S. Army Aviator qualified in one of the following: CH47D/F, UH60A/L/M, UH7A.
2. The ability to communicate effectively, both orally and in writing.
3. The skills required to supervise personnel.
4. Experience in consolidating and analyzing data, prioritizing workload to meet organizational goals.

Summary of Duties: The AASF commander ensures the legal, efficient, and safe management of state aviation assets. Responsible for all management of the AASF requirements including training maintenance and readiness of aircraft, aircraft sub systems, and allied systems, AASF supply support requirements plus AGR and Technician personnel management. The AASF Commander is responsible for managing the Additional Flight Training Program (AFTP) for support of MTOE and TDA unit personnel training IAW NG Pam 750-2. Plan, execute, and operates NGB/AMC/AMCOM Policies, plans and guidance under the supervision of the Director of Aviation and Safety. Supports all assigned units Aviation Commander's Aircrew Training Program for State and Federal missions. Requests operating level input, develops and makes recommendations to the Director of Aviation and Safety for program revision or improvement. Ensures resolution of recurring problems. Identifies and initiates new projects or solutions as required to manage and oversee assigned programs. Attends meetings and/or workshops as a Director of Aviation and Safety representative and may act as a working member on special councils and readiness committees. Drafts supplemental, policies, guidance, and comprehensive reports which may include statistical data and evaluations. Participates in the NEARNG Organizational Inspection Program to ensure and maintain regulatory compliance with governing directives.

Conducts special investigations of unusual incidents as required and develops comprehensive reports of findings. Performs other duties as assigned.

Yes No 3. Last five OER's/NCOER's. Applications must contain their most current OER/NCOER and if unavailable written explanation must be provided. A letter of recommendation or performance must be submitted if you don't have any OER's/NCOER's. ____ (Initials)

Yes No 4. NGB 23 (RPAM). All Army National Guard Soldiers must submit a NGB 23 dated **within 6 months of closing date**. For non ARNG members, contact the AGR Branch for other options. ____ (Initials)

Yes No 5. Statement of all active duty performed (DD Form 214, DD Form 215, DD Form 220, or any other forms that show active-duty service). **Statement of all Active Duty performed is not required for AGR personnel**. ____ (Initials)

Individual Training Report (ITR) form DTMS showing ACFT and Height/Weight. **The record ACFT score must be passing with a date within 12 months for M-Day and within 6 months for AGR of closing date. ___ **Yes** ___ **No** 8. Applicants will be screened for profiles (the DA 3349 is not required to be sent). Temporary profiles **MUST** be cleared prior to AGR start date. Any permanent profiles with a PULHES of 3 or 4 must be supported with a Medical Fit for Duty. ___(Initials)

___ **Yes** ___ **No** 9. Any additional information/memorandums/letters of recommendation may be submitted that you feel will help qualify your application or for any “no” responses identified on this checklist. ___(Initials)

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail, postal mail, or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
