Position Title: Assistant Operations NCO (113405) Location: HHT 1/134<sup>th</sup> CAV (IBCT), Yutan, NE

Military Grade Range: Minimum SGT/E5 - Maximum SSG/E6

Military Requirements: Designated MOS for this position is 19D. Selected individual must become MOS qualified within 12 months of appointment. Must possess and maintain a valid SECRET security clearance. Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.

## Qualified applicants will be referred to the selecting official in the following order.

**Area 1:** Lateral Transfers of **on-board** AGR personnel (SSG/E6) MOS 19D qualified. Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: Select Train Educate Promote List (STEP) of on-board AGRs CPMOS qualified (SGT/E5, 19D).

Area 3: Transfers of on-board AGR personnel with a minimum grade of (SGT/E5) eligible to attain MOS 19D.

**Area 4:** All members of the Nebraska Army National Guard, or those eligible to become members currently holding the rank of SGT/E5 and above.

#### **General Requirements:**

- 1. The ability to develop procedural/regulatory guidance.
- 2. The ability to communicate effectively, both orally and in writing.
- 3. The ability to work with automation equipment and information technology systems.
- 4. Experience in consolidating and analyzing data, prioritizing workload, and managing time to meet organizational goals.
- 5. Knowledge of military training standards and operational procedures.

Summary of Duties: Track training schedules to ensure compliance with directives, policies, NEARNG 350-1, and ammunition requests. Assists in coordination and preparation for training areas and ranges. Accomplishment of the unit's training objectives and missions; Plans and submits requisitions for training aids, training areas, and ammunition utilizing RFMSS and TAMIS; Develops and updates training events commensurate with the Commander's training objectives; Responsible for periodic testing of alert mobilization directives and regulations; Prepares requests for Army schools through ATRRS and inputs requests for orders and travel authorizations through DAMPS and DTS; Supervises the Operations Specialist(s); Advises and assists subordinate direct reporting unit Readiness NCO's and subordinate BN S3 personnel on the completion of their assigned duties. Responsible for execution of Commander's plans and programs to attain the unit's training objectives and mission. Prepare reports, briefs, and correspondence. Responsible for school requests through ATRRS and orders input in DAMPS. Advise personnel on military education and prepares applications for service schools. Keeps the Battalion Commander informed on individual training status of the

unit personnel. Coordinates with higher headquarters for current and future training requirements. Performs other duties as assigned.

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail, postal mail, or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
