Military Requirements: Designated MOS is 01A. CPT/O3s must NOT currently be non-selected for promotion by a DA board or in a SELCON status. Must possess and maintain a SECRET security clearance. Officers with a currently revoked, denied or suspended clearance or failed to maintain a favorable NACLC investigations are not eligible for appointment into a Position of Significant Trust and Authority (POSTA) position. Selectee must work weekends and evenings as the position and circumstances require. Selected individual must possess a valid state driver's license. No record of conviction by special or general court-martial or civilian courts of offenses listed in AR-27-10 Chapter 24 or required to register as a sexual offender. Drug and alcohol review of both the Drug Testing Portal and Drug Management Information System. Must meet POSTA screening as identified in ARNG-HRZ, PMOM #15-040, dated 16 December 2015 and as updates or changes are required. Applicants will review the qualifications for this position. Failure to review these qualifications may result in the applicant not being eligible for the position.

Area of Consideration: All members of the Nebraska Army National Guard, and individuals eligible to become members, meeting the minimum requirements may submit applications for this position. All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date of the announcement.

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Technician positions also require the OF 306 and Application/Resume.
