ACTIVE GUARD RESERVE VACANCY ANNOUNCEMENT

Position Title: Training NCO (12815)

Location: 623rd EN CO, Mead, NE

Military Grade Range: Minimum SGT/E5 - Maximum SSG/E6

Military Requirements: Designated MOS is 12H. Applicant must be eligible to hold the 12H MOS and complete MOS requirements within 12 months of assignment. Must possess and maintain a valid SECRET security clearance. **Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.**

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. **All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.**

Qualified applicants will be referred to the selecting official in the following order.

Area 1: On-board AGR Soldiers (SSG/E6) who are 12H qualified or eligible to be qualified within 12 months. Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: Select Train Educate Promote List (STEP) of on-board AGRs CPMOS qualified (SGT/E5, 12H).

Area 3: On-board AGR Soldiers in the grade of SGT/E5 regardless of qualified MOS who meet the military requirements as listed above.

Area 4: All members of the Nebraska Army National Guard and individuals eligible to become members with a rank/grade of SGT/E5 and above may submit applications for this position. This position is a SSG/E6 and a reduction will be required for any applications above the rank/grade of SSG/E6 prior to AGR start date.

General Requirements:

1. The ability to consolidate and analyze data.
2. The ability to develop procedural/regulatory guidance.
3. The ability to apply personnel management practices and techniques.
4. The skills required to supervise personnel.
5. The ability to communicate effectively, both orally and in writing.

Summary of Duties: Responsible for accomplishing the Commander's plans and programs to attain the company training objectives and mission. Reviews training schedules to ensure compliance with directives, policies and AR 350-1, Assists in the coordination and preparation of training areas and ranges. Prepares reports, briefing materials, and correspondence related to company status and requirements. Directly responsible for processing school requests through ATRRS and orders input through DAMPS. Advises personnel on military education requirements and processes applications for Army service schools. Provides individual training records and keeps the Commander informed on individual training status of the company personnel. Responsible for training activities in caring for the welfare of company Soldiers through the use of DAMPS, iPERMS, MARRS-N, RFMSS, TAMIS, DTS, and DTMS. Performs other duties as assigned.

Electronic applications will be submitted as one PDF attachment named "*Last Name, First Name, AGR-AR-__-__ (list job announcement number)*". Applications submitted in multiple attachments will not be accepted. Applications or attachments which are unreachable or cannot be opened will not be accepted or considered.

***Candidates may apply by submitting a completed *Application for Active Guard/Reserve (AGR) Position*, NGB Form 34-1. Reference AR 135-18 Para 2-3 and NGR 600-5 Para 2-4 the following documents must be submitted. Packets without the appropriate documents or a written explanation will not be processed for interviews. Applicants will use the *Application Checklist* to ensure proper documentation is submitted. The *Application Checklist* can be downloaded from the Nebraska National Guard Opportunities webpage.**

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
