Position Title: Training NCO (108)

Location: HHD-JFHQ, Lincoln, NE

Military Grade Range: Minimum SGT/E5 - Maximum SSG/E6

**Military Requirements:** Designated MOS for this position is 00F. Must meet the physical fitness standards in FM 7-22, the weight standards in AR 600-9, and ALARACT 248/2010 the Amy Weight Control Program. Applicant must possess and maintain a SECRET security clearance.

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.

#### Qualified applicants will be referred to the selecting official in the following order.

**Area 1:** Lateral Transfers of **on-board** AGR personnel (SSG/E6). Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: Select Train Educate Promote List (STEP) of on-board AGRs (SGT/E5, 00F).

Area 3: Transfers of on-board AGR personnel (SGT/E5).

**Area 4:** All members of the Nebraska Army National Guard, or those eligible to become members currently holding the rank of SGT/E5 and above. This position is SSG/E6 and a reduction will be required for any selected applicants above the rank/grade SSG/E6 prior to AGR start date. Area 4 start date will be effective on or after 1 April 2025.

#### **General Requirements:**

- 1. Experience using ATTRS, TAMIS, DTMS, DTS, RM Online, DAMPS, IPPS-A, and MyUnitPay.
- 2. Experience in applying problem solving techniques resolve training management and fiscal issues.
- 3. Experience in consolidating and analyzing data, prioritizing workload, and managing time to meet organizational goals.
- 4. The ability to interpret regulatory guidance and prepare training guidance.
- 5. Ability to communicate effectively orally and in writing.
- 6. Ability to become ACFT Administrator, Height and Weight Evaluator, and PRT instructor.

**Summary of Duties:** Responsible for accomplishing the Commander's plans and programs to attain the unit's training objectives and mission. Drafts training scheduled to ensure compliance with directives, policies and the NEARNG REG 350-1. Prepares reports, briefing material and correspondence. Advise personnel on military education requirements and prepares applications for service schools. Prepare individual training records and keeps the Commander informed on the individual training status of the unit personnel. Responsible for the overall supervision and entry of all military education courses, orders, personnel, and administrative activities in caring for the welfare of unit.

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
