AREA OF CONSIDERATION: Open to any current commissioned officer members of the Nebraska Air National Guard or members eligible to join the Nebraska Air National Guard, currently serving in the grade of 0-6 (or O-5 promotable within a year) with the AFSC of 4XXX

**QUALIFICATIONS:** Applicant must already be commissioned with the rank of Colonel (or promotable to Colonel). Prior experience is mandatory in a medical command position, or experience in one or more senior health care management positions within preceding 5 years. Senior health care management positions include Chief, Hospital or Clinic Services; Chief Nurse; Base Dental Surgeon; Chief, Aerospace Medicine; Administrator; Chief of Pharmacy, Laboratory, or other biomedical sciences function; or other clinical or health care service or department-level management positions. Must have 4 years retain-ability. Fully deployable.

**DUTIES:** Commands medical operations, leading medical units and personnel to deliver quality healthcare services and ensure mission support. This includes determining healthcare needs, developing plans and policies, managing resources, and implementing programs like disaster preparedness. Also coordinates healthcare activities through various channels, advises the installation commander, and collaborates with external agencies to optimize healthcare delivery and community health planning.
