Position Title & Unit: Ammo Supply NCO,
Det 1 Training Center Command

Location: Hastings, NE

Military Grade Range: Minimum (SGT/E5) - Maximum (SSG/E6)

Military Requirements: Designated DMOS for this position is (89B3O). A security eligibility of **SECRET** is required for this MOS. Must meet the physical demands requirements of DA Pam 611-21. MOS qualification, if required, must be completed IAW current policy and training guidance. Selected individual may incur additional training requirements for SQI and/or ASI requirements for the duty position (see unit specific requirements below). The qualifications for the award of this MOS can be found in DA Pam 611-21.

Area of Consideration: All eligible and available members of the Nebraska Army National Guard or eligible personnel available for transfer into the Nebraska Army National Guard serving in the grade range listed above. In order to be promoted in this position, the selected Soldier must be fully qualified for promotion IAW AR 600-8-19.

General Requirements:

1. Currently assigned (SGTE5 - SSG/E6) in the Nebraska Army National Guard or any personnel eligible for transfer into the Nebraska Army National Guard
2. Not currently "Flagged from Favorable Personnel Actions", under a "Bar to Reenlistment", or defined as "Stagnant".
3. Meet other requirements as stated in **Military Requirements** above.

Summary of Duties: Performs duties in the preceding skill levels, supervises junior grade Soldiers and provides technical guidance to the Soldiers in the accomplishment of their duties. Prepares/reviews ammunition storage waivers. Prepare complex ammunition malfunction reports. Ensures ammunition quality assurance/quality control procedures are followed.

Other Unit Unique Considerations/Requirements: Must possess a valid motor vehicle license from any of the 50 states or US territories either in photo ID or paper form in accordance with applicants issuing State or US Territory law(s) or regulations.

10-89B. MOS 89B--Ammunition Specialist (Ammo Sp), CMF 89 (Effective 202406)

a. *Major duties.* The ammunition specialist receives, stores and issues conventional ammunition, guided missiles, large rockets and other ammunition related items; performs maintenance, modification, destruction and demilitarization on ammunition and explosive components. Duties for MOS 89B at each level of skill are:

(1) *MOSC 89B10.* Assist in receipt, storage, issue, maintenance, modification, destruction and demilitarization of explosive items. Operate MHE to maneuver ammunition.

(2) *MOSC 89B20.* Performs duties in preceding skill level, supervises junior grade Soldiers and provides technical guidance to the Soldiers in the accomplishment of their duties. Assist in the preparation of transportation of ammunition, ammunition components and explosives.

(3) *MOSC 89B30.* Performs duties in the preceding skill levels, supervises junior grade Soldiers and provides technical guidance to the Soldiers in the accomplishment of their duties. Prepares/reviews ammunition storage waivers. Prepare complex ammunition malfunction reports. Ensures ammunition quality assurance/quality control procedures are followed.

(4) *MOSC 89B40.* Performs duties in preceding skill levels, supervises junior grade Soldiers and provides technical guidance to the Soldiers in the accomplishment of their duties. Interprets technical data and instructs subordinates in the technical aspects of ammunition, missile and other explosive items receipt, storage, maintenance and supply. Technical advisor on ammunition surveillance and safety matters.

(5) *MOSC 89B50.* Performs duties in preceding skill levels, supervises junior grade Soldiers and provides technical guidance to the Soldiers in the accomplishment of their duties. Supervises and manages the SAAS-MOD at Theater Sustainment Command Distribution Management Centers (TSC DMC), Expeditionary Sustainment Command Distribution Management Centers (ESC DMC), Ammunition Supply Activities at the Sustainment Brigade and TSC levels, Brigade Ammunition Office (BAO) and Ammunition Transfer Holding Points (ATHP). Assists in the survey and layout of areas allocated for the establishment of ammunition storage areas. Plans requirements for labor, equipment and supplies in preparation and application of plans, work policies and procedures.

(6) *MOSC 89B60.* Performs duties in preceding skill levels. Responsible for advising echelons above brigade on strategic munitions sustainment related issues. Operates as a liaison, ensuring mutual understanding, and the direct link to commanding general in the Army Field Support Battalion. Logistical advisor on plans, policies, and training of munitions and deployment operations.

b. *Physical demands rating and qualifications for initial award of MOS.* Ammunition specialists must possess the following qualifications:

(1) A physical demands rating of Significant (Gray).

(2) A physical profile of 222221.

(3) Normal color vision.

(4) Qualifying scores.

(a) A minimum ASVAB score of 91 ST or a combination of 86 ST and 85 GT.

(b) A minimum OPAT score of Standing Long Jump (LJ) – Four Feet, Seven Inches, seated Power Throw (PT) – 13 Feet, One Inch, Strength Deadlift (SD) - 0140 lbs., and Interval Aerobic Run (IR) - 0040 shuttles in Physical Demand Category in “Significant” (Gray).

(5) A security eligibility of favorable National Agency Check with Local Agency Check and Credit Check (NACLIC), per AR 380-67, App B-2b.

(6) Formal training (completion of MOS 89B course conducted under the auspices of the US Army Ordnance School (USAOS)) to include Phase II MOS training for RC personnel is mandatory.

(7) Non-allergic to explosive components.

(8) Non-claustrophobic tendencies.

(9) A U.S. citizen.

c. *Additional skill identifiers.* (Note: Refer to table 12-8 (Listing of universal ASI's associated with all enlisted MOS.)) R1--Rough Terrain Container Handler (RTCH).
