Position Title & Unit: Command Sergeant Major, 402nd Military Police Battalion

Military Requirements: Designated MOS for this position is 31Z6O. A security clearance of SECRET is required for the initial award of MOS. The selected individual will complete the Battalion pre-command course within 6 months of assuming CSM duties. Exceptions to this timeline will be handled on an individual basis.

Area of Consideration: Lateral (maximum grade) and those currently eligible to pin on the maximum grade. Applicants must be on the current calendar year's Best Qualified STEP list.

General Requirements:

1. Not currently "Flagged from Favorable Personnel Actions" or under a "Bar to Reenlistment"
2. Meet other requirements as stated in Military Requirements above.
3. E9 AGR Soldiers must be assigned to an equal graded E9 full-time support position IAW NGR 600-5 and must attain CLASP approval prior to assignment (three-year CLASP Tour).
4. AGR E8's are INELIGIBLE to apply.

Summary of Duties: The CSM is the senior NCO in the command at the battalion level. The CSM carries out and enforces policies and standards on performance, training, appearance, and conduct of the organization. The CSM is the principal advisor to the commander, giving advice and making recommendations to the commander and staff on matters pertaining to the organization. The CSM is responsible for enlisted talent management and ensures all aspects of the NCO C3 are present in the operational domain.

Other Unit Unique Considerations/Requirements: None
