Military Grade Range: Minimum (E5/SGT) - Maximum (E7/SFC)

Military Requirements: Designated DMOS for this position is 68W4F. Selectee must have a current Flight Physical to apply for this position. Individual must meet and maintain Flight Medic requirements as part of this position. Must meet the physical demands requirements of DA Pam 611-21. MOS qualification, if required, must be completed IAW current policy and training guidance. Selected individual must already have the ASI F2 awarded for the duty position (see unit specific requirements below). Applicant must hold a SECRET security clearance. The qualifications for the award of this MOS can be found in DA Pam 611-21.

Area of Consideration: All eligible and available members of the Nebraska Army National Guard serving in the grade range listed above. To be promoted in this position, the Soldier must be fully qualified for promotion IAW AR 600-8-19.

General Requirements:

- 1. Currently assigned E5/SGT E7/SFC of the Nebraska Army National Guard that are 68W MOSQ and F2 qualified
- 2. Not currently "Flagged from Favorable Personnel Actions", under a "Bar to Reenlistment", or defined as "Stagnant".
- 3. Meet other requirements as stated in **Military Requirements** above.

Summary of Duties: The Medevac Platoon Sergeant is an assistant and advisor to the commander, with the responsibility of training and caring for soldiers. As the senior NCO involved in the company METL, platoon sergeants teach collective and individual tasks to soldiers in their team. Administers emergency medical treatment to battlefield casualties and is trained in aeronautical medicine and all equipment associated with patient transport and rescue by rotary winged aircraft. Also capable of performing pre, in flight, and post flight crew duties in accordance with local SOPs.

Other Unit Unique Considerations/Requirements: This is a UH-72 Lakota helicopter non-rated crewmember flying position. Position requires completion of Readiness Level (RL) progression and must become RL1/Day/Night/NVG qualified before promoting in this position. Annual flight hour requirements will be fulfilled utilizing Additional Flight Training Periods (AFTP), Unit Training Assemblies (UTA), and Annual Training (AT). Soldier must be F2 qualified and have a passing flight physical to be assigned to this position

Other Unit Unique Requirements: This Unit/position will be mobilized from January through September 2026.

10-68W. MOS 68W Combat Medic Specialist (Combat Medic Sp) CMF 68 (Army Civilian Acquired Skills Program (ACASP) designated MOS)

- a. *Major duties*. The combat medic specialist provides emergency medical treatment, limited primary care, force health protection, evacuation in a variety of operational and clinical settings from point of injury or illness through the continuum of military health care and, as a field combat medic, provides emergency medical care/treatment at point of wounding on the battlefield or to battle and non-battle casualties during wartime.
- (1) MOSC 68W1O. Administer emergency medical treatment to battlefield casualties, assists with outpatient care and treatment or assists with inpatient care and treatment under the supervision of a physician, nurse, physician's assistant or a combat medic NCO. Instructs platoon Combat Lifesaver/First Responder 40 hour training course and annual recertification. Responsible for platoon level personnel medical readiness, medical supplies and equipment.
- (2) MOSC 68W2O. Administers emergency and routine medical treatment to battle and non-battle casualties, assists with outpatient care and treatment and supervises field and clinical medical facilities under the supervision of a physician, nurse, or physician's assistant. Serves as a team leader/supervisor to subordinate combat medical specialists and lead instructor of company Combat Lifesaver/First Responder medical training. Conducts company level medical planning. Supervises unit personnel medical readiness, requests medical supplies, and performs triage NCO duties.
- (3) MOSC 68W3O. Supervises activities of field, clinical and mobile treatment facilities. Serves as squad leader/section supervisor. Optimizes the use of Class VIII medical supplies and resources. Develops medical standard operating procedures (SOPs). Performs medical interventions with a higher technical ability. Principal trainer of squad/section personnel.
- (4) MOSC 68W4O. Supervises para-professional medical service activities in large fixed and mobile treatment facilities. Serves as medical platoon sergeant/detachment NCO or clinic NCOIC. The organization's senior medic and medical training NCO. Responsible for all unit combat medics, medical equipment/supplies, and coordination of key resources. Mentor of the junior medical officer/platoon leader.
- (5) MOSC 68W5O. Supervises and provides technical guidance within the Army Medical Department and Army Special Staff Activities. Serves as First Sergeant, the senior enlisted advisor to the medical company commander. As Master Sergeant, serves as senior medical planner, operations, or intelligence NCO for battalion sized units and above. Department NCOIC in large medical treatment facilities.
- b. *Physical demands rating and qualifications for initial award of MOS.* Qualifications in subparagraphs (8), (9), (10), (11), (12) and (13) below are required for retention of MOS. The combat medic specialist must possess the following qualifications:
 - (1) A physical demands rating of Significant (Gray).
 - (2) A physical profile of 111121.
 - (3) No aversion to blood.
 - (4) Must possess finger dexterity in both hands.
- (5) Per AR 600-8-19, promotion to MSG and SGM requires an interim eligibility clearance or higher.
 - (6) Qualifying scores.
 - (a) A minimum score of 101 in aptitude area ST, effective 9 October 2023.
- (b) A minimum OPAT score of Standing Long Jump (LJ) 0140 cm, Seated Power Throw (PT) 0400 cm, Strength Deadlift (SD) 0140 lbs., and Interval Aerobic Run (IR) 0040 shuttles in Physical Demand Category in "Significant" (Gray).
 - (7) Have a high school diploma or GED equivalency.

- (8) No history of alcoholism, drug addiction, indiscriminate use of habit-forming or dangerous drugs.
- (9) Must maintain a current, valid, unrestricted National Registry Emergency Medical Technician (NREMT) Certification (Emergency Medical Technician or higher) and a current basic life support for healthcare providers certification to retain MOS 68W. MSGs/1SGs are exempt from this requirement.
- (10) Must maintain a current and unrestricted individual skills qualification within two years, documented is the 68W Medical Operational Data System (MODS) to retain MOS 68W. MSG/1SGs are exempt from this requirement.
 - (11) No history of a felony conviction.
 - (12) No history of conviction of crimes involving:
 - (a) An out of hospital patient or a patient or resident of a medical care facility.
 - (b) Financial exploitation of a person entrusted to the care of the applicant.
 - (c) Any weapons/ammunition/explosives/arson charges.
- (d) Any drug activity involving illegal possession, buying, selling, or distribution (dealing) of controlled substances or synthetics.
 - (e) Violence against persons, animals or property.
 - (f) Sexual misconduct.
- (13) No record of conviction by special or general courts-martial or civilian courts of offenses listed in AR 27-10 (Military Justice) chapter 24 or otherwise required to register as a sexual offender under AR 27-10, chapter 24.
- (14) Formal training (completion of MOS 68W course conducted under auspices of U.S Army Medical Center of Excellence) mandatory; or completion of the Exportable 68W1O Course conducted by reserve component (RC) unit approved by the MEDCoE; or meet the ACASP criteria per paragraph 9-5b(7)(b) of this pamphlet. Soldiers will be accelerated to the Army specific portion of the course (Limited Primary Care) if they hold one of the following certifications with the National Registry of Emergency Medical Technician (NREMT): EMT, Advanced EMT, or Paramedic. Depending on determination of their certification expiration date, Soldiers will be accelerated to the next available class beginning in the Limited Primary Care Module.
- (15) All prior MOS 68W Soldiers serving in another MOS reclassifying back into MOS 68W, will be reviewed for validation of skills, by the proponent, during the reclassification process.
- c. Additional skill identifiers: (Note: Refer to table 12-8 (Listing of universal ASI's associated with all enlisted MOS)).
 - (1) F2 -- Critical Care Flight Paramedic (skill level 1-5 only).

Title: Critical Care Flight Paramedic

Proponent: U.S. Army Medical Center of Excellence (MEDCoE)

a. Description of positions. Identifies flight paramedic positions requiring Soldiers who are Nationally Registered Paramedic (NRP) Certified. The Critical Care Flight Paramedic has the primary requisite skill sets to provide critical pre-hospital trauma care, trauma management, advanced cardiac life support care

and management to patients, as well as ability to administer blood products during aerial evacuation above and beyond the traditional skill sets of a NREMT Certified 68W, Combat Medic Specialist. b. Qualifications.

- (1) Meet and maintain all sustainment requirements for MOS 68W.
- (2) Have successfully passed the NRP certification examination and maintain all sustainment requirements IAW the National Registry of Emergency Medical Technicians.
- (3) Possess a current and qualified Class 3 Flight Physical.
- (4) Must successfully complete the following MEDCoE Courses:
- (a) 081-300-F1 (P), Combat Paramedic Course (68W Soldiers who apply for ASI F2 and are already NRP qualified will be exempt from requiring this course).
- (b) 081-300-F2, Critical Care Paramedic Course (68W Soldiers who apply and have obtained Critical Care Emergency Medical Transport Paramedic Training (CCEMT-P) Certificate or Flight Paramedic Certification (FPC) with appropriate clinical experience as determined by the course director will be exempt from requiring this course).
- (c) 871-300-F3, AMEDD Aviation Crewmember Course (68W Soldiers who previously held 68W ASI F3 and completed 871-300-F6, Flight Medic Course will be exempt from requiring this course.
- (5) E8's serving in 68W5MF2 positions must have previously served in F2/F3 billets for no less than 48 months (24 months Platoon Sergeant/Detachment Sergeant time ideal) and are not required to maintain current NRP certification or have a valid Class III FDME. However, if these Soldiers volunteer for flight status and perform flight paramedic duties they are required to maintain a valid Class III FDME and a current NRP certification.
