Military Requirements: MOS Designated for this position 25U4P. Must meet the physical demands requirements of DA Pam 611-21. MOS qualification, if required, must be completed IAW current policy and training guidance. Selected individual may incur additional training requirements for SQI and/or ASI requirements for the duty position (see unit specific requirements below). The qualifications for the award of this MOS can be found in DA Pam 611-21. This assignment carries a requirement to become fully qualified within one year of assignment (or based on the availability of schools).

Area of Consideration: All eligible and available members of the Nebraska Army National Guard, serving in the grade of SSG/E-6 – SFC/E-7. To be promoted in this position, the Soldier must be fully qualified for promotion IAW AR 600-8-19.

General Requirements:

1. Currently assigned SSG/E-6 – SFC/E-7 of the Nebraska Army National Guard
2. Not currently "Flagged from Favorable Personnel Actions", under a "Bar to Reenlistment", or defined as "Stagnant" IAW PPOM 18-001
3. Meet other requirements as stated in **Military Requirements** above.

Summary of Duties: The signal support operations specialist supervises, installs, operates, deploys, maintains, troubleshoots, trains, and assists the General Purpose User (GPU) with Programs of Record (POR) and Commercial off the Shelf (COTS) communications equipment, as appropriate, within the Tactical Operations Center (TOC), Command Post (CP), vehicle platforms, and dismounted. This includes information systems support for Mission Command Systems (MCS), Frequency Modulation (FM) Radio Systems, Tactical Satellite (TACSAT), High Frequency (HF) radio, Internet protocol (IP) based radio systems, vehicular and dismounted configurations; Performs Network Control Station and Network Management Operations for, Internet Protocol (IP) based radio systems, and other tactical radio communications systems. Configures and troubleshoots Local Area Networks and Routers. Recognizes Electronic Counter Measures (ECM) and implements Electronic Counter-Counter Measures (ECCM). Installs, operates, and maintains (IOM) POR and COTS field expedient antenna solutions. Performs field level unit maintenance on authorized C&E systems and COMSEC devices and prepares maintenance and supply requests for field level signal support. Disseminates and enforces signal policies and integrates signal systems and networks with adjacent units. IOM Radio Retransmission (RETRANS) operations and performs Preventive Maintenance Checks and Services (PMCS) on assigned vehicles and power generators.

10-25U. MOS 25U--Signal Operations Support Specialist (Sig Ops Spt Spc) CMF 25 (effective 202510)

a. *Major duties.* The signal operations support specialist supervises, installs, operates, deploys, maintains, troubleshoots, trains, and provides information systems support for Army radio systems, vehicular and dismounted configurations; Performs Network Management Operations for Internet Protocol (IP) based radio systems and other tactical radio communications systems. Configures and troubleshoots Local Area Networks and Routers. Installs, operates, and maintains field expedient antenna solutions. Performs field level unit maintenance on authorized communications and electronics systems and COMSEC devices and prepares maintenance and supply requests for field level signal support. Disseminates and enforces signal policies and integrates signal systems and networks with adjacent units. Installs, operates, and maintains Radio Retransmission (RETRANS) operations and performs Preventive Maintenance Checks and Services (PMCS) on assigned vehicles and power generators. Duties for MOS 25U at each level of skill are:

(1) *MOSC 25U10.* Installs, deploys, maintains, troubleshoots, and assists the GPU with POR and COTS communications equipment, as appropriate, within the TOC, CP, and vehicle platforms. This includes MCS, C&E, COMSEC devices, telephone wire, LANs, and routers. Performs field level unit maintenance on authorized C&E systems and COMSEC devices and prepares maintenance and supply requests for field level signal support. Disseminates and enforces signal policies. IOMs RETRANS operations and performs PMCS on assigned vehicles and power generators. Provides access to Network capabilities and performs NCS and Network Management Operations for tactical radio networks and automated local area networks.

(2) *MOSC 25U20.* Supervises, installs, deploys, maintains, troubleshoots, trains, and assists the GPU with POR and COTS communications equipment, as appropriate, within the TOC, CP, and vehicle platforms. Provides access to Network capabilities and performs NCS and Network Management Operations for tactical radio networks and automated local area networks. Supervises and performs field level unit maintenance on authorized C&E systems and COMSEC devices and prepares maintenance and supply requests for field level signal support. Disseminates and enforces signal policies. Supervises and IOMs RETRANS operations and supervises PMCS on assigned vehicles and power generators. Recognizes electronic countermeasures (ECM) and implements electronic counter-countermeasures (ECCM).

(3) *MOSC 25U30.* Plans, supervises, deploys, maintains, troubleshoots, trains, and assists the GPU with POR and COTS communications equipment, as appropriate, within the TOC, CP, and vehicle platforms. Provides access to Network capabilities and performs NCS and Network Management Operations for tactical radio networks and automated local area networks. Supervises and performs field level unit maintenance on authorized C&E systems and COMSEC devices and prepares maintenance and supply requests for field level signal support. Disseminates and enforces signal policies and integrates signal systems and networks with adjacent units. Supervises and IOMs RETRANS operations and supervises PMCS on assigned vehicles and power generators.

(4) *MOSC 25U40.* Plans, supervises, deploys, maintains, troubleshoots, and assists the GPU with POR and COTS communications equipment, as appropriate, within the TOC, CP, and vehicle platforms. Provides access to Network capabilities and performs NCS and Network Management Operations for tactical radio networks and automated local area networks. Plans and requests signal logistics support for field level operations and maintenance. Develops and implements Battalion and Company level training in the use of signal systems. Participates in and enforces the results of staff level planning that develops and disseminates signal policies, Operation Orders annexes, and various reports. Integrates signal systems and networks with adjacent units, coordinates external signal support, and provides technical advice to commanders and subordinate units. Plans and directs the RETRANS operations team and PMCS on assigned vehicles and power generators.

b. *Physical demands rating and qualifications for initial award of MOS.* Signal operations support specialists must possess the following qualifications:

- (1) A physical demand rating of Moderate (Gold).
- (2) Physical profile of 111221.
- (3) Qualifying scores.

(a) A minimum score of 95 in aptitude area EL and 95 in aptitude area SC.

(b) A minimum OPAT score of Long Jump (LJ) - 0120 cm, seated Power Throw (PT) - 0350 cm, Strength Deadlift (SD) - 0120 lbs., and Interval Aerobic Run (IR) - 0036 shuttles in Physical Demand Category of "Moderate" (Gold).

(4) Normal color vision.

(5) A security eligibility of SECRET is required for the initial award and to maintain the MOS.

(6) A U.S. citizen.

(7) Formal training (completion of MOS 25U course conducted under the auspices of the USA Signal School) mandatory.

(1) J7--WHCA Console Control Operations.

(2) Q6--Protection Cell Operations (skill level 4 through 6 for personnel only) (Effective 202410).

(4) 5C--Mission Command Digital Master Gunner (MCDMG)
