**Grade Requirement:** Chief Master Sergeant.

**AFSC Requirement:** No specific AFSC requirement

**Minimum Qualifications:**

- Must be willing to serve a minimum of two years up to a maximum of six years.
- Graduate of the Chief Master Sergeant Orientation Course (CMSOC).
- Must possess an associate degree or higher from a nationally or regionally accredited academic institution.
- Must possess current Secret (minimum) security clearance IAW DoDM 5200.02, AFMAN 16-1405, Air Force Personnel Security Program.
- Must have general knowledge of the AF Medical Services and of the 155 ARW/MDG mission.

**Specialty Qualifications/Requirements:**

- Must attend ANG/MDG Senior Leadership Course (SLC) and HAF/SG Combined Senior Leadership Course (CSLC) within 18 months of assignment to UMD duty position.

**Duties and Responsibilities include but are not limited to:**

- Execute the Group SEL responsibilities as outlined in The Enlisted Force Structure Book “Brown Book” dated 16 MAY 2022.
- Be the primary enlisted advisor to MDG/CC.
- Be responsible for the overall health, morale, and quality of life of the enlisted force.
- Be visible, accessible and engaged.
- Ensure a culture of dignity and respect.
- Interpret and enforce policies and directives. Ensure fair and equitable treatment of all Airmen.
- Ensure timely enlisted promotions, focus on retention and advise the MDG/CC on force management issues.
- Actively support and maintain robust recognition programs.
- Knowledge of Line of Duty (LOD), Medical Continuation (MEDCON), Disability Evaluation System (DES) along with Individual Medical Readiness (IMR) process
