**ACTIVE GUARD RESERVE VACANCY ANNOUNCEMENT**

**Position Title:** BLC Small Group Leader (13037, 13043)

**Location:** 1<sup>st</sup> BN, 209<sup>th</sup> RTI, Camp Ashland, NE

**Military Grade Range:** Minimum SGT/E5(P) - Maximum SSG/E6 (Two positions)

**Military Requirements:** Designated MOS for this position is 00F/Immaterial. Be a SSG or above; however, exceptions will be considered on a case-by-case basis to secure best qualified instructors. Proponent school Commandants may grant exceptions to otherwise qualified SGTs to fill instructor vacancies; must meet the physical standards in FM 7-22 and weight standards in AR 600-9 and ALARACT 24B/2010 the Army Weight Control Program; must currently hold SQI "8" or be able to attain within 6 months of assignment; possess a SECRET clearance or higher or be able to obtain a SECRET clearance.

**Area of Consideration:** All Soldiers of the Nebraska Army National Guard that hold the rank of SGT/E5(P) and above may submit applications for this position. **AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.**

**Qualified applicants will be referred to the selecting official in the following order.**

**Area 1:** Lateral Transfers of on-board AGR personnel (SSG/E6, 00F) complete with CFD-IC that possess Instructor ASI "8" or be able to become qualified within 6 months.

**Area 2:** Select Train Educate Promote List (STEP) of on-board AGR CPMOS qualified (SGT/E5, 00F) with skill level 3 leadership as documented on an NCOER or ERB, and complete with CFD-IC that possess Instructor ASI "8" or be able to become qualified within 6 months.

**Area 3:** N/A

**Area 4:** All members of the Nebraska Army National Guard currently holding the rank of SGT/E5 (P) and above. This position is SSG/E6 and a reduction will be required for any selected applicants above the rank/grade SSG/E6 prior to AGR start date. Complete with CFD-IC that possess Instructor ASI "8" or be able to become qualified within 6 months.

**General Requirements:**

1. Have no personal habits or character traits that are questionable from a security standpoint such as financial irresponsibility, unusual foreign holdings or interests, heavy drinking, drug abuse, gambling, emotional instability and so forth.
2. Have no speech impediments
3. Display good military bearing
4. Have a demonstrated ability to be an instructor
5. Have no record of conviction by special or general court-martial or civilian court of sexual offenses listed in AR 27-10 or otherwise be required to register as a sex offender under AR 27-10.

**Summary of Duties:** Conducts training in the Basic Leader Course (BLC) in accordance with the Program of Instruction (POI) and Course Management Plan (CMP), Instructor Certification Program (ICP), and the Unit SOP; performs duties of Senior Small Group Leader (SSGL) in their absence; responsible for the training and instruction of a 1:8-10 ratio of SGL/Student for 11 classes per year; performs counseling of students; advises SSGL on all evaluations and areas of improvement; evaluates and conducts tests of student performance in technical subjects and leadership development; counsels and re-trains as necessary; sets the standards of leadership, training, technical competence, and professionalism of Army NCOs; provides mentorship for students; conducts preparation for class cycles; coordinates required support for resources and equipment with SSGL; assists in development of work plans and training schedules with SSGL.

Yes  No 3. Last five OER's/NCOER's. Applications must contain their most current OER/NCOER and if unavailable written explanation must be provided. A letter of recommendation or performance must be submitted if you don't have any OER's/NCOER's. \_\_\_(Initials)

Yes  No 4. NGB 23 (RPAM). All Army National Guard Soldiers must submit a NGB 23 dated **within 6 months of closing date**. For non ARNG members, contact the AGR Branch for other options. \_\_\_(Initials)

Yes  No 5. Statement of all active duty performed (DD Form 214, DD Form 215, DD Form 220, or any other forms that show active duty service). **Statement of all Active Duty performed is not required for AGR personnel**.

Yes  No 6. Individual Training Report (ITR) form DTMS showing ACFT and Height/Weight. **The record ACFT score must be passing with a date of 1 April 2022 or later and within 12 months for M-Day and within 6 months for AGR of closing date. Height/Weight is considered current within 6 months of closing date**. You must provide written explanation if you are unable to provide ACFT scores. \_\_\_(Initials)

*To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.*

*In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.*

*Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.*

*Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Technician positions also require the OF 306 and Application/Resume.*
