ACTIVE GUARD RESERVE VACANCY ANNOUNCEMENT

Position Title: CBRN NCO Team Member (7219)

Location: 72nd CST, Lincoln, NE

Military Grade Range: Minimum SPC/E4(P)- Maximum SGT/E5

Military Requirements: Designated MOS for this position is 74D2R. Selected individual must attend Civil Support Skills Course (CSSC)-8 Weeks, plus all additional position required training within one year of assignment. Must be able to obtain and maintain a secret security clearance. Assignment incurs 3-year obligation to unit post CSSC completion **Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 <https://www.milsuite.mil/book/groups/smartbookdapam611-21> for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.**

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. **All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.**

Qualified applicants will be referred to the selecting official in the following order.

Area 1: Lateral Transfers of **on-board** AGR personnel (SGT/E5) MOS 74D qualified. Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: Select Train Educate Promote List (STEP) of **on-board** AGR CPMOS qualified (SPC/E4, 74D).

Area 3: Transfers of **on-board** AGR personnel (SPC/E4) eligible to attain MOS 74D.

Area 4: All Soldiers of the Nebraska Army National Guard who meet the minimum grade requirements (SPC/E4). This position is SGT/E5, and a reduction will be required for any selected applicants above the rank/grade SGT/E5 prior to AGR start date.

General Requirements:

1. Knowledge of the organization and structure of the Air and Army National Guard.
6. Ability to pass OSHA approved physical exam for Self-Contained Breathing Apparatus (SCBA) wear which will be conducted after applicants are selected for the position.
7. Selectee will be required to complete Anthrax and Smallpox immunizations.
8. Normal Color Vision is required.
9. Required to live within 60 minutes of duty location; Lincoln, NE.

Summary of Duties: Enter areas of possible contamination to identify and assess CBRNE hazards; determines the source of the hazard and the extent of the contamination; participate in the collection of chemical and biological samples; initiate WMD CST chain of custody procedures and maintain the teams capability to properly set-up and operate state of the art CBRN equipment; know CBRN antidote administration; safe patient extraction; crime scene preservation techniques; perform all operational tasks while wearing all levels of PPE; able to identify NATO and TIC placards. Utilizes the established checklists and code words in reporting the detection, identification and sample collection actions in the Hot Zone/contaminated area. Total technical training requirements for this position are 739 hours which must be completed within 3 years of assignment in addition to applicable MOS and NCOES schools. May be assigned additional duties based on Unit and Section needs.

Yes No 2. ERB/ORB. Download your validated Selection Board Record Brief ERB/ORB from <https://minuteman.ngb.army.mil/benefits> . **Enlisted applicants who are not MOS qualified for the announced position must include ASVAB scores on their ERB**. ___(Initials)

Yes No 3. Last five OER's/NCOER's. Applications must contain their most current OER/NCOER and if unavailable written explanation must be provided. A letter of recommendation or performance must be submitted if you don't have any OER's/NCOER's. ___(Initials)

Yes No 4. NGB 23 (RPAM). All Army National Guard Soldiers must submit a NGB 23 dated **within 6 months of closing date**. For non ARNG members, contact the AGR Branch for other options. ___(Initials)

Yes No 5. Statement of all active duty performed (DD Form 214, DD Form 215, DD Form 220, or any other forms that show active duty service). **Statement of all Active Duty performed is not required for AGR personnel**.

Yes No 6. Individual Training Report (ITR) form DTMS showing ACFT and Height/Weight. **The record ACFT score must be passing with a date of 1 April 2022 or later and within 12 months for M-Day and within 6 months for AGR of closing date. Height/Weight is considered current within 6 months of closing date**. You must provide written explanation if you are unable to provide ACFT scores. ___(Initials)

Yes No 7. IMR (Individual Medical Readiness) or Flight Physical <https://medpros.mods.army.mil/medprosnew/secure/medical/imr.aspx> with a record **PHA completion date within 12 months of closing date**. ___(Initials)

Yes **No** **8.** Applicants will be screened for profiles (the DA 3349 is not required to be sent) . Temporary profiles **MUST** be cleared prior to AGR start date. Any permanent profiles with a PULHES of 3 or 4 must be supported with a Medical Fit for Duty. (Initials)

 Yes **No** **9.** Any additional information/memorandums/letters of recommendation may be submitted that you feel will help qualify your application or for any “no” responses identified on this checklist. (Initials)

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail, postal mail, or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
