**Military Grade Range:** Minimum MSG/1SG-E8 - Maximum SGM/CSM E-9

**Military Requirements:** Designated CPMOS for this position is 19Z6O. Applicants must possess a Security Clearance of Secret and meet the physical demand requirements of DA Pam 611-21. Selected individual may incur additional training requirements for SQI and/or ASI requirements for the duty position (see unit specific requirements below). The qualifications for the award of this MOS can be found in DA Pam 611-21. Must be enrolled or have completed the Sergeant Major's Academy Course for consideration. Qualifications to be assigned in a CSM position can be found in NGR 600-200, Chapter 7.

**Area of Consideration:** All eligible and available members of the Nebraska Army National Guard, serving in the grade of E8 or E9 with current standing on the Command Sergeants Major Selection List.

(Qualified applicants will be referred to the selecting official in the following order)

**Category 1:** Lateral Transfers of current SGM/CSM E9 applicants.

**Category 2:** Current MSG/1SG E8 applicants with a standing on the CSM Selection List.

**Under the direction of the State CSM, qualified applicants will be referred for interviews.**

**General Requirements:**

1. Not currently "Flagged from Favorable Personnel Actions" or under a "Bar to Reenlistment"
2. Meet other requirements as stated in Military Requirements above.
3. E9 AGR Soldiers must be assigned to an equal graded E9 fulltime support position IAW NGR 600-5 and must attain CLASP approval prior to assignment (three-year CLASP Tour).
4. AGR E-8's are INELIGIBLE to apply.

**Summary of Duties:** The Squadron CSM is the principal enlisted advisor to Battalion and higher Commanders. Establishes and executes policies and standards pertaining to performance, care, conduct, appearance, personnel, management and training of enlisted personnel; Provides advice and makes recommendations to Squadron Commander and staff on matters pertaining to enlisted personnel; Accompanies the Squadron Commander on inspections, visits, and at ceremonies; Assists with inspections of Squadron activities as prescribed by the commander; Responsible for the Squadron's First Sergeants/Detachment Sergeants and their duties.
