Minimum Qualifications:

- Must have or be able to attain 48 months of retainability.
- Must have demonstrated strong leadership, managerial skills, and strong public speaking skills.
- Must have a 7 level or 9-level in any AFSC.
- Must have completed the USAF NCO Academy Course.

Area of Consideration: This announcement is open nationwide. All current enlisted members of the Nebraska Air National Guard and those eligible to become members. Members currently holding a CE Operations AFSC.

Specialty Qualifications:

- Must complete Electrical Systems Apprentice Course within one year of position selection, if not prior Electrical Systems.
