Military Grade Range: Minimum SSG/E6 - Maximum SFC/E7

Military Requirements: Designated MOS is 92Y. Selected individual must become MOS qualified within 12 months of appointment. Must meet the physical demands requirements of DA Pam 611-21. Must possess a valid state motor vehicle operator's license. Must possess and maintain a valid SECRET security clearance. Selected individual may incur additional training requirements for SQI and/or ASI requirements for the duty position (see unit specific requirements below). Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.

Qualified applicants will be referred to the selecting official in the following order.

Area 1: Lateral Transfers of **on-board** AGR personnel (SFC/E7) MOS 92Y qualified. Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: Select Train Educate Promote List (STEP) of **on-board** AGRs CPMOS qualified (SSG/E6, 92Y). **Area 3:** Transfers of **on-board** AGR personnel (SSG/E6) MOS 92Y qualified.

Area 4: All Soldiers of the Nebraska Army National Guard, who meet the minimum grade requirements (SSG/E6). This position is SFC/E7 and a reduction will be required for any selected applicants above the rank/grade SFC/E7 prior to AGR start date.

General Requirements:

- 1. The ability to research and interpret regulatory guidance and policies.
- 2. The ability to implement and manage programs.
- 3. Review and consolidate reports, statistics, and applications and prepare recommendations.
- 4. The skills required to supervise and manage staff.

Summary of Duties: Lead Full Time Staff sustainment planner for the Battalion and supervises Soldiers engaged in supply, services, materiel management and logistics operations. Serves as principal NCOIC for supply and services for the Military Police Battalion. Supervises and assists in the planning of operations of three subordinate organizations performing supply and related service operations and is able to predict requirements. Oversee and maintain logistical data provided by GCSS-Army automated system. Contributes to staff development and operations of supply support data systems, equipment review, and maintenance support systems. Conducts assistance visits to subordinate elements. Manages all battalion accountable officer transactions to include lateral transfers, turn ins, inventories and excess management. Determines required method of relief from responsibility for lost, damaged and destroyed property/equipment items (FLIPLs). Conducts CSDP, CDDP and CMDP inspections as needed for subordinate units. Responsible for managing and overseeing all subordinate units CIF actions, AFMIS review, CCDF review, and operational task

list items. Develops and executes training programs. Assistance facility manager for the North Omaha Readiness Center and Billing Official for all subordinate units. Assists the S4 OIC in development of the Sustainment portion of orders production and Annex F.

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

Applications may be submitted by e-mail, postal mail, or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
