Position Title: Training Officer (37614)

Location: D Co, 1-376th AV REGT, Grand Island, NE

Military Grade Range: Minimum WO1/W1 - Maximum CW4/W4

Military Requirements: Designated assignment for this position is 153L. Selected individual must be MOS and LUH-72A qualified within 12 months from AGR start date. Must have a current flight physical. Must possess and maintain a SECRET security clearance. **Applicants will review the qualifications for the award of this AOC in Department of the Army Pamphlet (DA PAM) 600-3 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.**

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. **All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.**

Qualified applicants will be referred to the selecting official in the following order.

Area 1: Lateral Transfers of **on-board** AGR personnel (CW4/W4). Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: N/A

Area 3: Transfers of on-board AGR personnel (WO1- CW3).

Area 4: All Soldiers of the Nebraska Army National Guard, or those eligible to become members, who meet the minimum grade requirements of WO1.

General Requirements:

1. Knowledge of a wide range of training methods.
2. Knowledge of training programs, policies, and procedures.
3. Knowledge of military organizations, equipment, and occupational specialties.
4. Knowledge of the mobilization process and policies.
5. Skills to plan, assess, and evaluate training.

Summary of Duties: Full-time unit staff OIC for D Co, 1-376th AV. Supports the successful accomplishment of the commander's unit training and readiness objectives. Assist the Commander in the development of the company long range and short-range training plans. Plans, coordinates, supervises, and participates in activities pertaining to the administration of the Aviation Company in all operations. Coordinates training resources including training areas, training aids, rations, facilities, ranges, and aviation training. Assists commander with managing additional duties and required training IAW AR 350-1, FM 7-0, ADP 7-0, and other applicable regulations. Proficient in DTMS, DTS, ATRRS, and DAMPS. Maintain currency and proficiency in UH-72 IAW TC 3-04.11 and ATM. Other duties as assigned.

Yes No 3. Last five OER's/NCOER's. Applications must contain their most current OER/NCOER and if unavailable written explanation must be provided. A letter of recommendation or performance must be submitted if you don't have any OER's/NCOER's. ____ (Initials)

Yes No 4. NGB 23 (RPAM). All Army National Guard Soldiers must submit a NGB 23 dated **within 6 months of closing date**. For non ARNG members, contact the AGR Branch for other options. ____ (Initials)

Yes No 5. Statement of all active duty performed (DD Form 214, DD Form 215, DD Form 220, or any other forms that show active-duty service). **Statement of all Active Duty performed is not required for AGR personnel**. ____ (Initials)

Yes No 6. Individual Training Report (ITR) form DTMS showing ACFT and Height/Weight. **The record ACFT score must be passing with a date within 12 months for M-Day and within 6 months for AGR of closing date. Height/Weight is considered current within 6 months of closing date**. You must provide written explanation if you are unable to provide ACFT scores. ____ (Initials)

Yes No 7. IMR (Individual Medical Readiness) or Flight Physical <https://medpros.mods.army.mil/medprosnew/secure/medical/imr.aspx> with a record **HIV draw within the last 2 years and PHA completion date within 12 months of closing date**. ____ (Initials)

Yes **No** **8.** Applicants will be screened for profiles (the DA 3349 is not required to be sent). Temporary profiles MUST be cleared prior to AGR start date. Any permanent profiles with a PULHES of 3 or 4 must be supported with a Medical Fit for Duty. ____ (Initials)

Yes **No** **9.** Any additional information/memorandums/letters of recommendation may be submitted that you feel will help qualify your application or for any “no” responses identified on this checklist. ____ (Initials)

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail, postal mail, or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
