Location: JFHQ, Lincoln, NE

Military Grade Range: Minimum SGT/E5 - Maximum SSG/E6

Military Requirements: Designated MOS is 00F with feeder MOS of 42A or 36B. Selected individual must become MOS qualified within 12 months of appointment. Must possess and maintain a valid SECRET security clearance. Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.

Area of Consideration: All members of the Nebraska Army National Guard and meeting the minimum requirements may submit applications for this position. All current hiring procedures will be in accordance with NEARNG Selection Process Policy guidelines. AGR's within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.

Qualified applicants will be referred to the selecting official in the following order.

Area 1: Lateral Transfers of **on-board** AGR personnel (SSG/E6, 00F) with a qualified feeder MOS of 42A or 36B. Soldiers on interim promotions will not be considered as Area 1 applicants.

Area 2: Select Train Educate Promote List (STEP) of **on-board** AGRs CPMOS qualified (SGT/E5) MOS 00F, feeder MOS 42A or 36B.

Area 3: Transfers of **on-board** AGR personnel with a minimum grade of (SGT/E5) MOS 00F, eligible to attain an MOS of 42A or 36B.

Area 4: All members of the Nebraska Army National Guard, or those eligible to become members currently holding the rank of SGT/E5 and above. Effective start date for Area 4 applicants will be on or after 01 April 2025.

General Requirements:

- 1. Knowledge of the principles and standard practices of management.
- 2. The ability to research and interpret regulatory guidance.
- 3. The ability to communicate effectively, both orally and in writing.
- 4. The ability to work with automation equipment and information technology systems.
- 5. Knowledge of ceremonies and protocol.
- 6. Knowledge of military personnel management and operational procedures.

Summary of Duties: Responsible for maintenance, accuracy, currency and validity of RPAM; initiates and controls RPAM data capture of newly assigned Soldiers; responsible for the procurement control and analysis of prior service records; issues and verifies automated 20 year letters; develops and implements quality control for RPAM; administers the Survivor Benefit Plan elections; processes applications for retirement; provides assistance with data input into IPPS-A; provides guidance and counseling in all facets of military retirement; maintains working knowledge of all database systems utilized with the G1; assists grey area retirees with retirement issues and spouse with their annuity claims. Assist with NGB-22 / DD214-1 transition, input, and completion.

To qualify for initial entry in the AGR Program applicants must meet the eligibility requirements in AR 135-18 paragraphs 2-1, 2-2, and 2-3. IAW AR 600-8-2, Flagged ARNG and US Army Reserve (USAR) soldier may not apply for AD or ADT.

In order to comply with United States Department of Defense (DoD) requirements and ensure the safety and security of the missions, programs, property and personnel of the Nebraska Military Department and Nebraska National Guard, employees must obtain the appropriate background investigation and maintain the level of security clearance assigned to their respective work.

Failure to obtain and maintain the designated type of security clearance/background check required for the respective work, may result in a job offer being rescinded, separation of employment, and/or other actions as may be deemed in the best interest of the agency.

Prior to appointment individuals must meet the security clearance requirements for the position or submit the required documents to the Nebraska National Guard Personnel Security Manager for processing the appropriate investigation. Required forms for AGR positions – SF 86, PSIP Initiation Form, Birth Certificate (or other proof of citizenship) and Fingerprints. Technician positions also require the OF 306 and Application/Resume.

The use of official mail to forward employment applications is prohibited. Applications submitted using government postage will not be considered.

Applications may be submitted by e-mail, postal mail, or hand-delivered to the HRO no later than 1600 hours on the closing date. Applications received after the closing time will not be considered for the position.
