Chief Warrant Officer Five Kenneth M. Henderson was appointed the sixth Command Chief Warrant Officer for the Nebraska Army National Guard on 6 July 2018. As the Command Chief, he serves as the Senior Warrant Officer Advisor to the Adjutant General to address the development and strength management of the Warrant Officer Cohort. CW5 Henderson currently serves as the Warrant Officer Senior Advisory Council Chair. CW5 Henderson began his career for the Nebraska National Guard in 1982 as a 63H Heavy Wheel and Track Mechanic, D Company Maintenance. He attended Warrant Officer Candidate School and was appointed to Warrant Officer One on 26 June 1998. He returned from WOCS to be the Squadron Maintenance Technician in the 1-167th Cavalry (CAV) from June 1998 to July 2007. During his assignment in the 1-167 CAV, he deployed to Bosnia, Herzegovina, October 2002 to September 2003, and then again to Iraq in support of Operation Iraqi Freedom (OIF), 06-08 October 2005 to June 2007.

CW5 Henderson's education includes Warrant Officer Candidate School, Warrant Officer Basic Course, Warrant Officer Advanced Course, Warrant Officer Staff Course, Total Army Instructors Training Course, TAC Officer Certification, Warrant Officer Senior Service Education Course, and he has a bachelor's degree in business management from Bellevue University.
