**ACTIVE GUARD RESERVE VACANCY ANNOUNCEMENT**

**Announcement Number:** AGR-AR-19-036

**Closing Date:** 23 May 2019

**Position Title:** Senior Supply Sergeant

**Location:** Lincoln, NE 68503

**Military Grade Range:** Minimum SSG/E6 - Maximum SFC/E7

**Military Requirements:** Designated MOS for this position is 92Y4R. Selected individual must become MOS qualified within one year from date of selection. Must be able to obtain and maintain a SECRET security clearance. WMD-CST personnel will sign an agreement for a 36 month stabilization tour. The stabilization of 36 months commences upon graduation from Civil Support Skills Training (CSSC). **Applicants will review the qualifications for the award of this MOS in Department of the Army Pamphlet (DA PAM) 611-21 for further demand rating and qualifications for initial award of MOS. Failure to review these qualifications may result in the applicant not being eligible for the position.**

**Area of Consideration:** All Soldiers of the Nebraska Army National Guard in the rank of SSG/E6 and above may submit applications for this position. **AGRs within 24 months of initial tour or 18 months of assignment or reassignment of closing date of this announcement requires a stabilization waiver. Stabilization waiver request must be submitted with application by closing date.**

**Qualified applicants will be referred to the selecting official in the following order.**

**Area 1:** Lateral Transfers of on-board AGR personnel (SSG/E7).

**Area 2:** Select Train Educate Promote List (STEP) of on-board AGR CPMOS qualified (SSG/E6, 92Y).

**Area 3:** Transfer of on-board AGR personnel (SSG/E6) eligible to attain MOS 92Y

**Area 4:** All members of the Nebraska Army National Guard holding the rank of SSG/E6 and above. This position is SFC/E7 and a reduction will be required for any selected applicants above the rank/grade SFC/E7 prior to AGR start date.

**General Requirements:**

1. Selectee will be required to pass an OSHA physical exam.
2. Selectee will be required to complete Anthrax and Smallpox immunizations.
3. Normal color vision is required.
4. Must complete the Civil Support Skills Course (CSSC, 8 weeks) and meet all job qualifications and requirements within 1 year.
5. Must reside within 60 miles of the duty location; Lincoln, NE.

**Summary of Duties:** Responsible for the procurement, accountability and storage of all equipment needed for incident response. Maintains property book accountability for assigned equipment. Uses the WMD CST GPC – to obtain (mission essential or replacing damaged) supplies, tools and equipment needed for the execution of WMD CST missions. Monitors status of all assigned equipment. Coordinates calibration requirement of equipment on hand. Procures supplies and equipment. Establishes a process to monitor expiration dates on expendable materials. Arranges for unserviceable equipment to be repaired or replaced. Arranges for warehousing of supplies and equipment including establishing a security program.

**DA PAM 611-21**

**10-92Y. MOS 92Y--Unit Supply Specialist (Unit Supply SPC), CMF 92**

a. *Major duties.* The unit supply specialist supervises or performs duties involving request, receipt, storage, issue, accountability and preservation of individual, organizational, installation and expendable supplies and equipment. Duties for MOS 92Y at each level of skill are:

(1) *MOSC 92Y10.* Receives, inspects, inventories, loads, unloads, segregates, stores, issues, delivers and turns-in organization and installation supplies and equipment. Operates unit level computers (ULC). Prepares all unit/organizational supply documents. Maintains automated supply system for accounting of organizational and installation supplies and equipment. Issues and receives small arms. Secures and controls weapons and ammunition in security areas. Schedules and performs preventive and organizational maintenance on weapons.

(2) *MOSC 92Y20.* Performs duties shown at preceding level of skill and provides technical guidance to junior grade personnel. Inspects completed work for accuracy and compliance with established procedures. Coordinates supply activities. Reviews and annotates changes to unit material condition status report. Posts transactions to organizational and installation property books, and supporting transaction files. Determines method of obtaining relief from responsibility for lost, damaged and destroyed supply items.

(3) *MOSC 92Y30.* Performs duties shown at preceding level of skill and provides guidance to junior grade personnel. Directs supply personnel in establishing supply and inventory control management functions. Maintains property under Property Book Unit Supply Enhanced (PBUSE) system. Reviews daily and monthly records of issues of petroleum products and operating supplies. Provides technical assistance to equipment records and parts specialist. Assists and advises supply officer and commander.

(4) *MOSC 92Y40.* Performs supervisory and management duties shown at preceding level of skill. Analyzes statistical data and reports to ascertain trends, conformance to standard and directives and efficiency of operations. Coordinates logistical activities with other staff elements, supply and service and motor transport units. Conducts assistance visits to subordinate elements. Develops and executes training programs.

(5) *MOSC 92Y50.* Supervises development and preparation of operations information. Plans, maps, sketches, overlays and analyses related data to employ supply and service organizations. Contributes to staff development and operations of supply support data systems, equipment review, salvage, and repair parts supply procedures. Performs liaison between staff and supported personnel to improve effectiveness of support activities. Conducts inspections and provides technical assistance to the Inspector General.

b. *Physical demands rating and qualifications for initial award of MOS.* Unit supply specialist must possess the following qualifications:

(1) A physical demands rating of heavy.

(2) A physical profile of 222222.

(3) Qualifying scores.

(a) A minimum score of 95 in aptitude area CL in Armed Services Vocational aptitude Battery (ASVAB) tests administered prior to 2 January 2002.

(b) A minimum score of 92 in aptitude area CL on ASVAB tests administered on and after 2 January 2002 and prior to 1 July 2004.

(c) A minimum score of 90 in aptitude area CL on ASVAB tests administered on and after 1 July 2004.

(4) Normal color vision.

(5) Mandatory formal training.

(6) Soldiers reclassifying into the MOS cannot exceed the rank of SGT (Active Component only). (7)

No documented instances in the last 5 years of conduct which reflects adversely on the character, honesty, or integrity of the Soldier to include:

(a) No conviction by court-martial or by any Federal or state court.

(b) No juvenile adjudication by state court.

(c) No punishment under Article 15, Uniform Code of Military Justice (UCMJ) caused by incidents that reflect adversely on the Soldiers integrity and lack of trust.

(d) No letter of reprimand, censure, or admonition under the provisions of AR 600-37, chapter 3.

(e) Voluntary confession after proper rights warning according to Article 31(b), UCMJ, or under applicable Federal or state law. Note: Disqualification under this paragraph is waivable by a military review board.

(8) No other record of disciplinary action under UCMJ or pattern of behavior which indicates a lack of integrity or which is inconsistent with the 92Y position of trust.

(9) No conviction or other adverse disposition for criminal offenses listed as a misdemeanor or felony as outlined in AR 601-210, chapter 4. This criteria is not waivable.

(10) Per AR 600-8-19, promotion to MSG and SGM requires an interim secret eligibility or higher.

c. *Additional skill identifiers.* (Note: Refer to table 12-8 for (Listing of universal ASI's associated with all enlisted MOS)).

(1) F7--Pathfinder (skill level 1-3 only).

(2) 3C--Operational Contract Support (OCS) (SSG thru SGM) (Effective 201310).
